

To request Early Childhood Education (ECE) Prior Learning Credits at Blue Mountain Community College (BMCC), you (the student) must initiate this process. Criteria to apply for credit:

- You must be enrolled in BMCC courses during the term in which you are requesting credit. NOTE: You should **not** register for the course that you are requesting prior learning credits for.
- Payment for each course must be done prior to transcription of course/s. The fee is \$10 per course.
- You will receive a grade of "P" for each approved course.

Transcription of credit will not be done until all fees have been paid. **NOTE: Request MUST be made and paid for in the same academic term that verification of enrollment has been done. Requests will not be accepted or processed without appropriate supporting documentation.**
